# PHIL/SAN 250: Critical Thinking in Advaita Vedānta Ph.D. Seminar, Fall 2013, Wed. 3-6 PM

#### **Course description:**

This course concerns critical thinking both *within* and *about* the philosophical tradition of Advaita Vedānta. We will read and discuss recent scholarly literature concerning some of the most important and interesting philosophical controversies and puzzles raised both by Advaitin thinkers themselves and by their philosophical opponents such as Rāmānuja and Madhva. For instance, does Śaṅkara lapse into eisegesis in his efforts to find characteristically Advaitic doctrines—such as the doctrine of *upādhi*-s and the illusoriness of the universe—in the Upaniṣads, the *Bhagavad Gītā*, and the *Brahmasūtras*? What is the nature of *avidyā*? What is the role and ontological status of *Iśvara* in Śaṅkara's philosophy? Is the *jīvanmukta* fully liberated or does the *jīvanmukta* have a trace of ignorance that accounts for the *jīvanmukta*'s continued existence in the body? Do Gauḍapāda and Śaṅkara hold different views on the question of whether the waking and dream states are on an ontological par? Is there *avidyā* in the state of deep sleep? Is *nirvikalpa samādhi* necessary for *brahmajñāna*? Does Swami Vivekananda's modern exposition of Advaita Vedānta differ substantially from Śaṅkara's Advaita Vedānta? Each week, we will discuss tricky philosophical questions such as these.

Each week, every student is expected to write a 1-2 page critical response to the assigned article, which both summarizes the main points of the article and critically discusses different aspects of the article. Each student will read their critical response out loud at the beginning of class, and our discussion will start from points raised in these critical responses. At the end of the semester, students must submit a final research paper (15-20 double-spaced pages) on any topic relating to the philosophy of Advaita Vedānta.
